ANSWER KEY

- **Q.1**: (a) Both assertion and reason are true and reason is the correct explanation of assertion. Agriculture is a primary activity, which produces most of the food that we consume. Two-thirds of India's population is involved in agricultural activities and earns livelihood through it.
- **Q.2**: (d) Both assertion and reason are false. Cultivation methods have changed significantly depending upon the characteristics of physical, environmental and technological methods. Agriculture is definitely an old economic activity in India. Thus, both reason and assertion are false.
- **Q.3**: (a) Both assertion and reason are true and reason is the correct explanation of assertion. The plantation has an interface of agriculture and industry.
